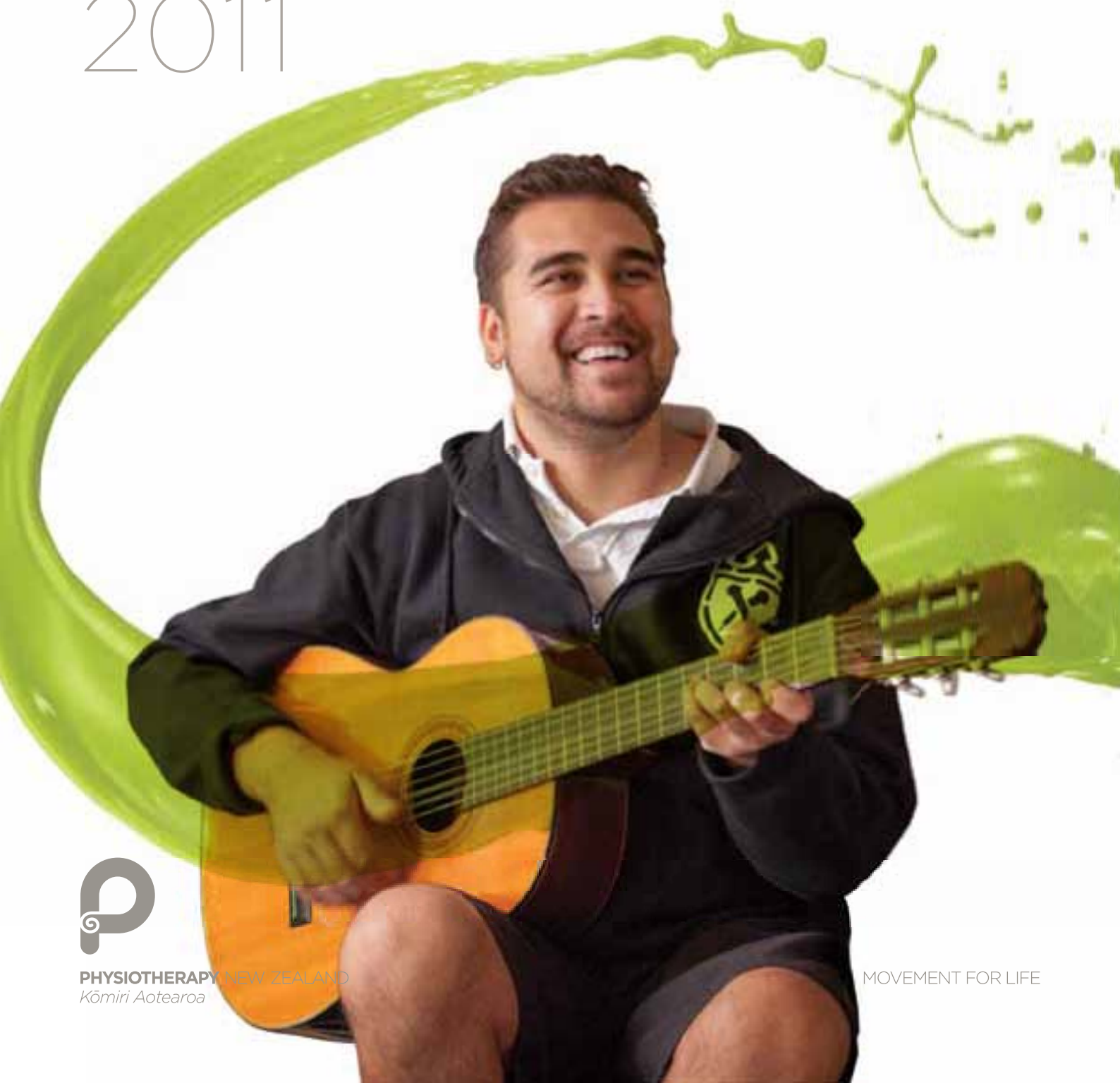

PROMOTING SUSTAINABLE, QUALITY REHABILITATION

Our focus for the year was on our future role of providing quality rehabilitation to all New Zealanders within a sustain-able model, and on promoting what we do. This report is organised according to the outcomes expected in our strategic plan.

Healthier New Zealanders through delivery of quality physiotherapy services

What a great sense of achievement in December, when the Physiotherapy Board ratified the *Aotearoa New Zealand Physiotherapy Code of Ethics and Professional Conduct!* This was a joint effort between Physiotherapy New Zealand and the Board. We are grateful to Dr Lynley Anderson for her facilitation, consultation, and development of this key piece of work.

To help members align themselves with the changing needs of the health and disability sector, we provided continuing education and information. A workshop during the August SIG/ Branch seminar exploring the question, "How can the physiotherapy profession become more responsive to population health needs?" brainstormed ideas to inform National Executive planning.

A healthy sustainable physiotherapy workforce

Showcasing physiotherapy as first choice for cost-effective physical health maintenance and rehabilitation, we supplied Workforce New Zealand with examples of innovative physiotherapy programmes.

Our strategic plan recognised the need to support new graduates within an ever-changing environment which poses many challenges to the whole profession. Accordingly, our support package was released near the end of the year in time for new graduates' entry to the workforce.

Support provided to Māori, particularly Māori students, through Tae Ora Tinana

should help increase the number of Māori physiotherapists and the profile of Māori within the profession.

Promote the value and understanding of physiotherapy to the public and the wider health sector

Early in the year National Executive accepted a marketing and communications plan aimed at raising awareness about the benefits of physiotherapy. The first focus for raising awareness, on arthritis and physiotherapy, began in September.

As President, I met with key stakeholders in the health and disability sector, continuing to advocate strongly for physiotherapy.

A strong vibrant Physiotherapy New Zealand that advances the profession

Reaction to the 22 February earthquake in Christchurch shows the strength and resilience of the profession. The National Executive decision to devote considerable resources to supporting Canterbury members proved important for those members' wellbeing.

National Executive and Tae Ora Tinana finalised their partnership agreement, a basis for both groups to work more effectively together and better understand each other's perspectives and needs.

We have strengthened links between the various groups within Physiotherapy New Zealand, and gained from their perspectives.

To align members' skills with changing demands, National Executive decided to employ a specialist who will develop and co-ordinate relevant upskilling.

I was privileged to represent Physio-

therapy New Zealand at the World Confederation for Physical Therapy General Meeting and Congress in Amsterdam in June. Quite a large contingent of New Zealand members attended the congress – some presenting, all stimulated by the learning, the ideas and the buzz of 5,000 delegates from 105 countries.

Globally the messages are much the same as those we promote here. For instance, the World Health Professions Alliance aims, "to strengthen health care systems to ensure an integrated and collaborative approach by health professionals in prevention, specialist treatment and rehabilitation." We can influence health policy by a clear unified message presenting solutions.

Dr Margot Skinner continues her devoted and inspirational work on the Executive of WCPT and in the Asia West Pacific Region.

We maintained a close relationship with the Australian Physiotherapy Association.

I want to thank Martin Chadwick, Lynda Kirkman and Lynne Taylor, who left National Executive in May, for sharing their expertise and giving their time so generously in the interests of the wider profession. Ian d'Young, Greg Knight and Karen Rasmussen, who were elected in May, joined Dave Nicholls, Denis Kelly and me, melding quickly into a hard-working unit whose sights are firmly set on our strategic goals. Many thanks to all.

The Society is its members, without whose support nothing could be achieved. Communication – working together – is vital to our profession. I offer particular thanks to the Kaitiaki of Tae Ora Tinana and the various committees who selflessly give their time and talents. I also acknowledge the sterling work of our Executive Director Karen McLeay and her committed, friendly and professional team.

PLANS IN ACTION

My report concentrates on how the National Office team carried out the actions laid down in our 2011 business plan, to achieve our strategic outcomes. I want to acknowledge and thank my team for their support and hard work to achieve our goals.

Healthier New Zealanders through delivery of quality physiotherapy services

- Building on the new code of ethics, we revised the *Physiotherapy New Zealand Standards of Practice* which will be finalised in 2012 following consultation.
- We formed strong relationships with partner associations such as Arthritis New Zealand and the New Zealand Orthopaedic Association.
- We revised the Scholarship Trust Fund deed to encourage innovative research.
- We established a contract for member access to the EBSCO databases for members' research.

A healthy sustainable physiotherapy workforce aligned to meet the health needs of the population

- We published *Workforce Guidance for Employers and Physiotherapy New Graduates*. Editorials and articles in *Physio Matters* underlined the need to support those entering work.
- We drafted a position statement on supervision, for consultation in 2012.
- We began considering options for a career pathway.
- Students and others gained from the hui tauira (student hui) organised by Tae Ora Tinana.. Kaitiaki also hosted two indigenous Australian physiotherapists who presented at the hui, for a study tour.
- We held a CPD forum where topics aligned with our strategic goals.

- We provided information to encourage members towards electronic data communication.
- We gave administrative support to the College of Physiotherapy.

Promote the value and understanding of physiotherapy to the public and the wider health sector

- Our first venture into social media to promote the profession was a Facebook page in May, which quickly gained popularity.
- We used video for the first time when raising awareness about physiotherapy and arthritis,. Two five-minute videos on YouTube showing individuals' experience of physiotherapy each attracted several hundred viewers. Newspaper articles, radio, TV and Facebook also carried the message. We began planning the next focus for our awareness raising, on physiotherapy and respiratory health.
- We used our website strategically to promote physiotherapy. From mid-May to 31 December, the site had 30,700 unique visitors.
- We made submissions on a large number of consultative documents, and met with politicians, ACC, and other government agencies such as the Ministry of Health and Health Workforce New Zealand to advocate for physiotherapy.
- We strengthened ties with various health organisations. The Allied Health Professionals Associations' Forum addressed common concerns and promoted our professions.

A strong vibrant Physiotherapy New Zealand that advances the profession

At the end of the year we had 3,088 members, which was similar to the number at the end of 2010.

- Canterbury members kept on providing services despite all their difficulties. Other members offered all kinds of practical help. We kept close contact with affected members, and met with them in Christchurch, to establish their needs. After we appointed Nicola Green as Physiotherapy Earthquake Liaison and Support, she initiated various measures including subsidised counselling.
- Representatives from all our branches and special interest groups and Tae Ora Tinana attended the two Strengthening the Links seminars in Wellington. These have become essential for consulting our profession's leaders in order to align with necessary change.
- Most of our branches have consolidated their funds with ours, which allows them to retain financial independence while relieving them of accounting and auditing responsibilities and satisfying the PNZ audit requirements.
- We assisted several branches and special interest groups to update their rules and procedures.
- The return on Physiotherapy New Zealand investments increased, as did our revenue from advertising.
- Online payment of subscriptions and online membership applications increased.
- With David Nicholls we worked on the history pages of the website, for the 2013 centenary.

We welcomed new Kaitiaki Maarama Davis, Andrea Havell and Emma Webb, and acknowledge the continuing service of Kaitiaki Kate Haswell, Ann Mckellar, Katrina Byrant and Leroy Lawrence. Congratulations to Karen Rasmussen on her election to National Executive. And thanks to Ema Moore, on parental leave this year, and Jarrod Ria, who has faced some huge challenges to his health. Arohanui ki ngā koutou katoa.

The theme for the 2011 Hui-tauaira held at Manukanuka o Hoturoa marae in Tamaki-Makau-Rau was "Student Mentoring". Guest speakers were Ray Gates, Chair of the National Association of Aboriginal and Torres Strait Islander Physiotherapists, and Kingi Snelgar, lawyer and past president of the Māori Students Association at Auckland University. 22 students from AUT including 2 from Otago, 3 new graduates and 6 Kaitiaki, kaumatua, kuia and manuhiri (including a super-nanny Kuia) enjoyed a successful hui.

A hiko to introduce our manuhiri, Aboriginal colleagues Ray Gates and Marilyn Morgan, to Te Ao Māori, helped us to lay the foundations for a relationship which will hopefully benefit Indigenous Australian and Māori physiotherapy students, and enrich the entire physiotherapy profession in the future.

Initiated by the National Executive of 2008, a Treaty partnership agreement which clarifies the nature of our relationship and terms of engagement was completed. Throughout the process, we were supported by our kaumatua and kuia with whaikōrero from Matua Bill and his manutioriori, Whaea Pat.

ETHICS

Activities and achievements

Policy

This year saw a significant achievement in regard to the Code of Ethics. The previous *Guidelines for the Code of Ethical Principles*, ratified by the Society Annual General Meeting in 2003, was reviewed by Lynley Anderson, former chair of the Ethics Committee and Senior Lecturer at Otago University's Bioethics Centre, on behalf of both Physiotherapy New Zealand and the Physiotherapy Board of New Zealand. Following considerable work and wide consultation, the Physiotherapy Board ratified the new *Aotearoa New Zealand Physiotherapy Code of Ethics and Professional Conduct* in December. The Board sent a hard copy to every physiotherapist and the document is available on both the PNZ and Physiotherapy Board websites. The committee would like to express its gratitude for the time and effort invested by Lynley in this review.

Advice and education

We provided advice via correspondence to PNZ members throughout the year. We wrote a column providing advice to physiotherapists regarding the complexities of employment contracts and selling products to clients. With the review of the Code occurring this year, education was not a strong focus, but will be central to the committee's work in 2012.

Complaints

No complaints were reviewed by the committee in 2011. Any significant complaints were forwarded to the Physiotherapy Board for review.

Plans

In 2012, our focus will be on providing education opportunities relating to the new Code as well as invigorating the current case study resources.

Underpinning the *Physiotherapy Code of Ethics and Professional Conduct* will be the *Physiotherapy New Zealand Standards of Practice*, which have been revised by Dr Lynley Anderson and Janet Copeland to ensure that they align with the new *Physiotherapy Code of Ethics and Professional Conduct*. The *Physiotherapy New Zealand Standards of Practice* will come out for consultation early in 2012.

Activities and achievements

It has been a productive and rewarding year for the journal. The three issues included eleven peer-reviewed articles, three invited clinical commentaries, five clinically applicable papers and fourteen book reviews. Our section "Hand Made History" introduced in 2010 (a series of retrospective pieces to mark the lead-up to a hundred years of physiotherapy in New Zealand), continued with a historical paper and accompanying commentary in each issue.

The update of processes and documents continues to improve quality. Introduced in 2011 was a new attractive cover page. I met with Southern Colour Print to discuss improving the layout of the journal and the formatting of tables and graphs.

I joined the International Journal Editor's Group.

Acknowledgements

We acknowledge and thank Dr David Nicholls and Dr Julie Reeve, who resigned from our Honorary Editorial Committee during the year, for their significant contributions. Dr Karen Peebles and Dr Anna Mackey accepted invitations to join the Honorary Editorial Committee.

My gratitude for all the hard work of: Copy Editor Bryan Paynter, Janet Copeland, Amy Macklin, the Honorary Editorial Committee, and journal reviewers – invaluable in the smooth running of the Journal. I also extend my thanks to all Journal contributors.

Plans

We are presently updating the author instructions to ensure manuscripts are submitted in a standardised format. We will also introduce a checklist for authors to complete on submission to assist the formatting and editing process and to ensure that ethical approval has been documented in all manuscripts (as appropriate).

The 2012 March issue will publish all 2011 reviewers' names. Reviewers currently receive certificates acknowledging their contribution to the journal.

Application for Medline access for the Journal will be on the agenda for 2012.

Acknowledgements

Many thanks for the efforts by the group this year, and in particular to Martin for his leadership.

Activities and achievements

The role of the primary healthcare working party has been to identify strategies enabling the profession to develop a set of skills that address the changing face of health provision in New Zealand. The need for a shift towards a greater focus on population health, health promotion and preventative care, and on community-based interdisciplinary management of chronic conditions was identified in the 2009 report *Engaging in Primary Healthcare*.

In 2010 the group developed a series of educational module concepts outlining the key issues required to provide the profession with the practical skills to address this new environment. In 2011, the group focused on the transition from broad concepts to identifying a process where these might become a reality. The group presented its recommendations to the National Executive, and it was agreed that funding would be provided to enable this transition.

There now follows a process, to be led by Dr David Nicholls from National Executive, to develop a structured course delivering a practical, useful tool for the profession based on these modules. This course will incorporate both individual and group study, practical tasks designed to help physiotherapists address the changing health environment at a local and regional level, and an opportunity for shared experience, all with the help of a moderator experienced in the primary healthcare field.

Plans

We anticipate that the first of these courses will be available from August 2012. The working party will now change to an advisory board capacity to assist in their development.

HISTORY

100 YEARS OF NEW ZEALAND PHYSIOTHERAPY 1913-2013

Activities and achievements

We have been busy gathering more interviews, documents and archive records and further developing some of the material to appear on the history website in early 2013.

We have completed 50 oral history interviews. These interviews were partially edited and some completed to publishable standard.

Our document collection continues to expand. Some material has gone directly to the Hocken Library in Dunedin, which continues to support Physiotherapy New Zealand, and some remains in Auckland.

We embarked on three major archiving projects. Firstly a complete log of the contents of every *New Zealand Journal of Physiotherapy*, dating back to the first edition in September 1938. We also undertook to produce a full catalogue of all archives held at the Hocken Library and at Archives New Zealand in Wellington. This massive venture is ongoing and the work at Archives New Zealand may not be completed until the end of 2012.

We published pieces in the *Physio Matters* "Making History" column: on becoming a first contact profession; the Hanover Street pool in Dunedin; our work finding hidden treasures at Archives New Zealand; the opening of New Zealand's second school at ATI in 1972; and an overview of our oral history project.

Plans

Our plans for the centenary celebration are taking shape and we have made decisions about some ways we will promote it.

With only one year left, much of 2012 will be spent organising our assorted materials and incorporating them into the PNZ website. The bulk of the work for this five-year project should be completed by the end of the year.

Activities and Achievements

- In March we held a cultural competence DVD night.

The consolidated financial statements represent the combined financial activities of the New Zealand Society of Physiotherapists Inc (trading as Physiotherapy New Zealand), the Scholarship Trust fund and the Physiotherapy New Zealand Branches.

Physiotherapy New Zealand (Consolidated)

Surplus

The net surplus after tax was \$80,580. Revenue from subscriptions was \$1,139,267, an increase of \$31,057 over the previous year. Operating revenue is less than that received in 2010 because no conference was held in 2011.

Balance Sheet

Accumulated funds and reserves were \$2,888,506 as at 31st December 2011. Working capital was \$1,343,167 as at 31st December 2011.

During the year The Scholarship Trust Fund repaid \$1,000,000 of the funds they owed to Physiotherapy New Zealand. \$700,000 was deposited with First NZ Capital who set up an investment fund in September 2011. The market value of investments as at 31st December 2011 was \$1,934,990.

Scholarship Trust

The Scholarship Trust Fund had a total income of \$111,611. \$64,084 was allocated for scholarship grants in the year ending 31st December 2011. The market valuation of the investment portfolio (cash, bonds and equities) at 31st December 2011 was \$1,230,174, an increase of \$149,500. Scholarship Trust Equity is \$877,916.
